MEMORANDUM OF UNDER STANDING

Patiala (Punjab) License No. 9 issued by ADG of Police Security-cum-controlling Authority Punjab, hence forth called the first party and M/s Dynamic Security Agency through its proprietor, Mr. Harendra Kumar Singh having their Head Office at Vill- Abheypur, Teh. Sohna, Distt. Gurugram, Haryana, 122102, hence forthcalled second party have entered into an agreement in accordance with the following terms and conditions: -

- (a) The first party will impart training in accordance with the norms laid down vide Private Security Agency Regulation Act- 2005, & the schemes run by the institute from time to time of Govt. of India or State Govt., under MHERD/NSDC/DGET/MEPSC/ PSDM.
- (b) The second party will be responsible to send its all guards to the first party at the prescribed timings and place. They can also select guards from the pool of guards already trained by the institute under Govt. Schemes.
- (c) The second party will be responsible to ensure that the trainees conform to the physical standards as prescribed vide PSARA- 2005, PSARA Rules (2007). The trainees will be in possession of medical fitness certificates.
- (d) The second party will be responsible for verification of character and antecedents of the Trainees/ security guards/supervisors as required vide PSARA 2005 and PSARA Rules (2007) amended from time to time.
- (e) This agreement will be valid for a period of one year from the date of signing the agreement (w.e.f. 24-05-2023 to 23-05-2024) and will be renewed from time to time. During the term of this contract, all guards employed by the second party are required to undergo training as prescribed under the act.
